

TERMS AND CONDITIONS

Please carefully read the following terms and conditions which govern the use of the website www.locationcolombia.com, before starting its exploration or use. If you do not agree to these, we request that you refrain from accessing or browsing this website. To continue browsing constitutes an acceptance of the terms and conditions.

1. **Purpose**

The corporation Fondo Mixto de Promoción Cinematográfica (hereinafter, 'Proimágenes'), residing in the city of Bogotá, identified with tax identification number 830.046.582-4, through the website www.locationcolombia.com (hereinafter, the 'Website'), carries out activities of promotion of Colombia as a location for audiovisual works.

This includes, among other actions, to publicize the services rendered by Colombians and to guide producers about the possibilities and alternatives for their projects in Colombia in terms of incentives, logistics, locations, accommodation, national talent, permits and contacts. Additionally, the Website offers interactive tools for its users, such as the registry to be part of the directory of services (hereinafter, the 'Services Directory'), the consultation of a locations directory (hereinafter, the 'Locations Directory') and the application for the submission of audiovisual projects to the incentives under law 1556 (hereinafter, the 'Law 1556 Application').

Proimágenes does not pursue any profit, gain or commercial interest with the content or links that are posted on the Website and on the websites of other entities or companies, which are accessed through the Website. Proimágenes requests any user of this Website (hereinafter, the '<u>User</u>'), to carefully read these terms of use (hereinafter, the '<u>Terms and Conditions</u>') before starting its exploration or use. If the User does not agree to these Terms and Conditions we suggest they refrain from accessing or browsing this Website.

2. Contents

The Website is intended to provide the User with all kinds of information related to Location Colombia, a Proimágenes program, directed by the Colombia Film Commission.



















Notwithstanding, this information should not be considered as exhaustive, complete or that in any way satisfies all the User's needs.

The Website contains articles, literary and scientific works (hereinafter, the 'Information') related to Proimágenes or third parties, prepared by the Colombia Film Commission or by third parties, for information and dissemination purposes.

Proimágenes provides a translation of the Spanish version of the Website. The User accepts that the translation is offered only as a service and that the Spanish version of the Website's content will govern their relationship with Proimágenes. In the event that there are contradictions between the Spanish version and the English version of the Website, the Spanish version will prevail.

The Data Subject/User has the rights granted by Colombian regulations and the aforementioned policy, such as the right to know, update, delete and rectify his or her personal data; revoke his or her authorization to process them; and refrain from answering questions that involve sensitive data, if they are contemplated. 6. **Services Directory**

6.1. Registration:

Proimágenes, through the Colombia Film Commission, informs producers and directors interested in Colombia about the best possibilities and alternatives to carry out their projects. Through the Website, especially through the Services Directory, Proimágenes facilitates contacts with companies, production businesses, entities, and authorities of various kinds, for those interested in producing or post-producing in Colombia.

The User, who must be of legal age, may register in the corresponding window of the Website. Proimágenes may verify the information included by the User. In case of doubt regarding the information, Proimágenes will refrain from including said registration. The User declares, under oath, that all information provided is true and verifiable. The information is provided freely and knowing that it will be made available on the Website.

6.2. Conditions to register in the Services Directory:

In order for the Services Directory to have the most qualified persons and companies, Proimágenes may request that the Users who register comply with the following conditions:

- a) To have been a part of the crew (physical persons) or rendered services (legal entities) in at least one Colombian feature film released commercially in cinemas after 2003 or in a film, series or other audiovisual product that received an incentive from Cinematographic Development Fund (FDC), the Colombia Film Fund (FFC) or the CINA System. The credit of participation must be found in the end credits of the audiovisual product and may be confirmed with the producer.
- b) Advertising production companies must be part of the Colombian Advertising Film Association or be a company with proven experience in the production of commercials for national or international television channels.
- c) Television production companies must be part of Asomedios or be a company with proven experience in the production of programs for national or international television channels.
- d) Digital animation companies must be part of the Association of Filmmakers of Digital Animation and Video Games

6.3. Access to the Services Directory:

After completing the registration, the registered User will receive a confirmation to be able to access as administrator and control his or her information.

For newly registered users, the registration shall be enabled within a maximum of 5 working days. At that time, the User will receive confirmation.

If the registration is rejected, the User may request additional evaluation at info@locationcolombia.com.



















Once the registration is active, an update of the User's information will be requested periodically and automatically. If the data is not updated, it may be deleted from the Services Directory.

7. **Locations Directory**

Proimágenes, through the Colombia Film Commission, and in compliance with law 1556 and its purpose of promoting Colombian territory to produce audiovisual works, makes available a Locations Directory to the producers who wish to film in Colombia. The Locations Directory contains information by region about the characteristics and contact information of places available for filming in the country.

The Locations Directory is a tool to facilitate the job of producers interested in filming in Colombia. Proimágenes has carefully selected the information shown in the Locations Directory. However, it does not assume responsibility for the use that the User makes of it and does not warrant its veracity, timeliness, accuracy and/or reliability. The information provided is for illustrative purposes only.

8. Application for the submission of projects (Law 1556 of 2012)

8.1. Registration:

The User, who must be of legal age, may register by clicking the announcement 'Submit your project' on the Website. The User declares, under oath, that all of the information provided is true and verifiable. The information is provided freely and knowing that it will be part of the submission process to the incentives under law 1556.

The Law 1556 Application is a platform administered by a third party with whom Proimágenes maintains a commercial relationship. The operation of the Law 1556 Application is the exclusive responsibility of the third party administrator. Nevertheless, Proimágenes communicates constantly with the third party administrator to ensure the correct operation of the Law 1556 Application.

The Users who wish to submit their projects to any of the incentives provided under Law 1556 of 2012 must do it through the Law 1556 Application.



















Proimágenes does not receive submissions or documentation related to submissions by any other medium.

8.2. Accessing and uploading information to the Law 1556 Application:

Proimágenes, through the Colombia Film Commission, serves as Technical Secretariat for the Colombia Film Promotion Committee and it's the entity in charge of managing the processes provided in Resource Allocation Manual ('MAR'), which contains the conditions that projects interested in applying to the incentives under Law 1556 of 2012 must comply with.

After following the registration instructions, the User may begin to upload the information related to the project in accordance with the MAR requirements, which may be found here.

The project will be submitted only when the user has filled out all mandatory fields. If additional information is required or a document needs to be corrected, the management entity will contact the applicant producer. Once the information is complete, the User will be informed about the presentation of the project to the Colombian Film Promotion Committee for approval or disapproval, in the specific terms of the MAR published on the Website. When this process is completed, said result will be communicated.

9. Terms of use and restrictions of the Services Directory and the Law 1556 **Application**

- 9.1. The User undertakes not to give commercial value (sell, rent, exchange, etc.) to the Information provided or made available to the public on the Website.
- 9.2. Proimágenes may cancel the User's access to the Services Directory and/or the Law 1556 Application, if, according to the circumstances, it determines that said User is a recurring offender of the provisions of these Terms and Conditions.
- 9.3. Proimágenes reserves the right to decide if the information provided or uploaded to the Website violates the Terms and Conditions.



















- 9.4. Proimágenes may, at any time, without prior notice and at its discretion, remove the information provided by the User and/or cancel their registration from the Services Directory and/or the Law 1556 Application.
- 9.5. The User is solely responsible for maintaining the confidentiality of their information to enter their profile, once their inclusion is approved, as well as for restricting access to their computer. The User accepts any responsibility that may arise from the use of their account, the information included by them, as well as the reliability of their password.

10. **Intellectual Property**

The information that appears on the Website and other Proimágenes sites, as well as the graphic design, contents, trademarks and logos, are the exclusive property of Proimágenes or third parties that have authorized their inclusion or use, and have declared themselves to be the owners. All of these are protected by national regulations on intellectual property and by international treaties on the subject that the Republic of Colombia has signed and ratified.

The User may not use, market, exploit or modify in any way the trademarks of Proimágenes, its providers or third parties.

11. Terms of use of the Website

- 11.4. Will not disclose and/or provide information through the Website that contains viruses or harmful components.
